I subsequently used specific search terms such as 'audiovisual', 'installation', and 'video art' to identify a more specific subset and downloaded these records (see table 1). I extracted the 300-word contextual statements for each record and merged these into one document. This document was then fed into ChatGPT, in addition I fed in further contextual information culled from REF guidance documents. A thematic analysis was then conducted, and the results provided below.

## 300-Word Contextual Statement for "Octopuses and Other Sea Creatures"

"Octopuses and Other Sea Creatures," immersive audio-visual installation in Portsmouth Cathedral, was a creative inquiry into reconfiguring our socio-environmental subjectivity in response to the ecological crisis. Drawing on Armstrong's (2009) call for an ontological shift towards compassion and companionship, and Guattari's (1995) advocacy for a mental revolution, this project aimed to transform audience perceptions of the ocean from an alien otherworld to an interconnected ecosystem, using the octopus as a metaphor for nature.

The installation's methodology was a blend of interdisciplinary arts and environmental activism. Central to this was the use of Becci Louise's 'Octopus Story' poems, which narrated the journey. Video artist Kim Balouch's projections created an undersea world, while Rusty Sherriff's live sonic landscapes provided an immersive auditory experience. The audience journeyed through three acts: an introduction to the undersea world, interactive learning with mini 'octopus wisdom' installations, and a climactic encounter with a metaphorical octopus, facilitated by 'The Diver'. This structure was designed to foster a transformative experience, promoting a symbiotic relationship with the marine environment.

The project's outcomes were multifaceted. It enhanced my reputation as a creative practitioner and refined my approach to community arts curation. The audience feedback ranged from awe and appreciation to confusion, indicating the diverse impact of immersive art. However, the predominant response was one of engagement and transformation, suggesting success in achieving the project's primary aim.

On reflection, I recognise the need for further skill development in theatrical performance to enhance future immersive experiences. This project has established my position in the city's arts community and has informed the development of a new project, an opportunity to further explore performance elements in audiovisual installations.

This project exemplifies how immersive art can catalyse a shift in environmental consciousness, contributing significantly to the discourse on art's role in addressing the ecological crisis.
